New Ohio Chapter Bylaws in Effect

n September 2002, the Ohio Chapter members approved a number of changes in the Chapter's bylaws, the most significant of which creates a new category of membership and redefines who is considered an Active Member and eligible to vote.

Essentially the bylaws now state that individuals who are licensed in the State of Ohio and are members of the American Academy for Orthotists and Prosthetists are eligible for Active membership in the Ohio Chapter. Active Members are eligible to vote in all Chapter elections and hold office in the Chapter.

The bylaws change also created a new category of membership, the Associate category which includes those:

 who hold current "Registered Associate" or "Technician" certification from The American Board for Certification in Orthotics and Prosthetics, or;

- who hold current BOC
 Orthotic Fitter/Mastectomy
 Fitter Certification from the
 Board for Orthotist/Prosthetist
 Certification.
- Any certified or licensed individual who wishes to receive Associate Member discounts for Chapter meetings and other member benefits.

Associate Members are not eligible to vote or hold office in the Chapter.

These changes were made in recognition of the changes licensure has brought and the expanding need for educational programs for Ohio O&P and C.Ped practitoiners, as well as standardizing definitions (or the recognition) of technicians and nonmembers.

These changes expand what the Chapter is, and the population it seeks to serve.

Legislation on Fast Track

Physical Therapists Push For Self-Referral with Senate Bill 35

enate Bill 35 passed the Senate after only three hearings in committee. The bill will permit, under certain circumstances, the practice of physical therapy other than pursuant to the prescription or referral of a physician, dentist, podiatrist or chiropractor.

The bill does not change the current definition of physical therapy, which includes "the design, fabrication, revision,

Amendments May Reopen Door to Qualified Practitioners

f enacted, proposed legislation to amend the Practice Act for Orthotists, Prosthetists and Pedorthists may re-open the door to experienced, qualified O & P practitioners who missed the opportunity for Grandfathering, or who otherwise were unable to meet the initial requirements for licensing as currently set forth in Ohio Revised Code Chapter 4779.

New Window of Opportunity

On a time-limited basis — until January 1, 2005 — experienced practitioners with less than a 4-year college degree would have a new opportunity to gain Board approval to take the Ohio licensing examination. Qualified individuals are:

- those with an Associates
 Degree, by documenting at
 least 2 years' experience, at
 least 6 months of which has
 been under supervision
- those with a high school diploma or GED, by documenting at least 3 years' experience, while also possessing ABC or BOC certification.

Five other "pathways" are also defined in the proposal as the permanent minimum qualifications for examination. Each requires a Bachelor's degree, various combinations of work experience, residency programs, certificate programs, and national certifications are set forth as "options" to

demonstrate competence to test for the exam.

Supervision refinements

The working draft would also:

- allow the Board to define by rule the type of supervised experience that qualifies for licensure, eliminating the requirement that such experience only be gained under an Ohio-licensed practitioner;
- eliminate the requirement that an out-of-state licensee seeking licensure by reciprocity document a term of supervised experience;
- lessen from 8 months to 4
 months the supervised experience requirement for pedorthist
 candidates.

Other changes include:

- establishing an "Inactive License" status for licensees not practicing in Ohio, or practicing under another licensee's supervision
- reducing from 75 to 60 the number of CE units that duallicensed Prosthetist-Orthotists will need to accumulate during a three-year period
- establishing provisions for reinstatement of a lapsed license, and restoration of a suspended license.

Continuing Education Requirements for O, P and P Licensure: A Review

he O & P State Office of occasionally receives questions about the requirements for Continuing Education. We are including a review of information that has also been provided by the State Board of Orthotics, Prosthetics and Pedorthics.

The number of continuing education (CE) hours required for reporting for each discipline is as follows:

- For individual licensed as orthotist or prosthetist: 45 CE
- For individual licensed as prosthetist and orthotist: 75 CE units
- For individual licensed as a pedorthist: 32 CE units

The statute also specifies that the

CE units must first be reported to the Board at the time of a licensee's fourth license renewal, and must have been accrued during the 3year period prior to that renewal.

For example, if a licensee were first licensed in 2001, he or she will be required to report or "attest" to the appropriate CE accrual at the time of renewal for the 2005-2006 license period: units reported will have been accrued January 2002-December 2004.

If an individual were first licensed in 2002, 2003 would be his/her first license renewal and he/ she will be required to report or attest to appropriate CE accrual at the time of your renewal for the 2006-2007 license period; units will have been accrued January 2003-December 2005.

According to Section 4779-9-01 of the Ohio Revised Code, it is the licensee's responsibility "to maintain and keep all records to serve as documentation for any audit pertaining to the completion of Orthotics/Prosthetics Continuing Education (OPPCE) requirements, including, but not limited to: certificates of completion, transcripts, letters of attendance, or attendance registers." Records must be maintained for a period of four years beyond the renewal date requiring attestation of OPPCE compliance for the holders of a license issued under Revised Code sections 4779.10, 4779.11, 4779.12, 4779.13, 4779.16, and 4779.17, and for a period of three years or three renewal periods for the holders of a temporary license issued under section 4779.18 of the Revised Code.

Legible copies shall be sent to the board only in response to an audit. ■■

HIPPA: What You Need to Know Now

The HIPAA Privacy Regulations: A Compliance Challenge

his article is the first in a two-part series discussing the two most important compliance challenges facing the O&P field. This article includes basic information that you need to know in order to comply with the

HIPAA Privacy Regulations. The date for compliance with these regulations is April 14, 2003. The subject of the second article will be file documentation requirements to comply with the OIG Guidelines for Compliance for DME, Orthotics and Prosthetics.

HIPAA is the acronym for the Health Insurance Portability and Accountability Act of 1996. The Centers for Medicare and Medicaid Services (CMS) are responsible for implementing and monitoring various unrelated provisions of this law. At present, the part of HIPAA with which O&P businesses need to be concerned involves the use and disclosure of personal health information. Adopting uniform standards to address the security and privacy of personal health data is a major step by the government to address the public's growing concern regarding violations in the

confidentiality of personal health information. The privacy standards are structured in three sections: (1) restriction on the use and disclosure of certain health information; (2) establishment of individual rights regarding health information; and (3) establishment of administrative requirements to ensure confidentiality and appropriate use of health information.

Information protected by the HIPAA privacy regulations is called "personal health information" or "PHI." The privacy standards apply to any information, whether paper or electronic, that describes an individual's health status or other characteristics that identify or could be used to identify that individual. This information includes not only the patient's name and address and specific treatment information but also sex, ethnicity, and age. "Covered entities," or those to whom the HIPAA privacy regulations apply, include entities which provide direct treatment to patients, including O&P facilities; other "covered entities" include health plans and health care clearinghouses.

Forms Needed

You will need the following forms in order to be in compliance with the HIPAA privacy regulations by April 14, 2003:

- 1. Notice of Privacy Practices: You must give this document to all of your patients and have them sign and date an acknowledgment form which you will then maintain in that patient's file.
- 2. Consent: This form should be signed and dated by every patient. The form should then be maintained in that patient's file. It gives you permission to use the patient's personal health information for "treatment, payment or other healthcare operations." This consent form generally covers all of the purposes for which you might use the patient's PHI in your business. Once this form is signed, it can only be revoked in writing.
- 3. Authorization: A patient must sign and date this form for any uses or disclosures of PHI for any purpose other than treatment, billing, and healthcare operations. This would include the use of a photograph or video or the use of PHI for research purposes. Once this form is completed, signed, and dated, it should be main-

tained in the patient's file. Each authorization is effective for the specific purpose stated until it is revoked in writing.

4. Business Associate Agreement: You are also responsible to ensure that some of your business associates protect the privacy of your patient's individual health information with the same care as you provide. "Business associates" are defined as entities that perform a function or provide services involving PHI on behalf of covered entities; these include lawyers, accountants, billing and collection companies, and central fabrication

facilities. You should have all such persons or entities sign this agreement with you. It is a contract, and you should maintain these signed agreements in a separate file. The term "business associates" does not include others who are direct treatment providers, so that you do not need to have an agreement with physicians, physical therapists, or similar direct treatment providers.

The Department of Health and Human Services (DHHS) Office of Civil Rights is responsible for the enforcement of the HIPAA Privacy Rule, and there are both civil and criminal penalties for violations. Your patients will be glad to know that, as part of the high quality of care that they receive from you, their personal privacy is being protected by your compliance with HIPAA.

education and instruction in the use of various assistive devices including braces, splints, ambulatory or locomotion devices, wheelchairs, prosthetics and orthotics...."

However, this bill eliminates the need for a prescription from a referring physician. The bill's sponsor said forty-six other states have similar legislation

A previous bill received substantial opposition during the last legislative session and ultimately stalled. SB 35 was initially opposed by family physicians and chiropractors but passed after several amendments were agreed upon..
